II. Organizational Context

Under the guidance and direct supervision of the Deputy Resident Representative or Representative, the Legal Advisor is responsible for management of OHCHR programme within the thematic/sectoral areas assigned (legal). The Legal Advisor analyzes political, legal, social and economic trends and leads formulation, management and evaluation of programme activities within his/her portfolio, provides policy advice services.

The Legal Advisor leads programme support staff, coordinates activities of his/her legal area assigned. The Legal Advisor works in close collaboration with other thematic units team, OHCHR HQs staff and Government officials, technical advisors and experts, multi-lateral and bi-lateral donors and civil society ensuring successful OHCHR programme implementation.

Ensures effective management of the OHCHR legal and judicial programme within the thematic/sectoral areas assigned focusing on quality control from formulation to implementation of the country programme achieving the following results:</p> <ul style="list-style-type: none"> ❑ Effective application of legal instruments, establishment of management targets and monitoring achievement of results. ❑ Design and formulation of OHCHR programme within the area of responsibility, translating OHCHR's priorities into local interventions. Coordination of programme implementation with the executing agencies. Introduction of performance indicators/success criteria, targets and milestones. ❑ The Legal Advisor can perform functions of Manager Level 1 and support participating in the recruitment processes for projects. ❑ Substantive monitoring and evaluation of the projects, identification of operational and financial problems, development of legal and technical solutions. ❑ Follow up on thematic recommendations (legal). All exceptions are timely reported. ❑ Aggregate reports are regularly prepared on activities, outputs and outcomes.
